1. Person responsible for personal data:

The person responsible for personal data, i.e., H. The company that processes the personal data of the data subject is the company LJ Design s.r. o. with registered office in Požiarna 825/24 020 01 Púchov, IČO: 46944150, registered in the commercial register of the Trenčín District Court, department: Sro, filing number: 27470/R (hereinafter referred to as "Operator").

The Operator processes personal data in accordance with Law 122/2013 on the Protection of Personal Data, as amended, and other legal provisions (hereinafter referred to as "Law No. 122/2013"). From May 25, 2018, instead of Law No. 122/2013, the operator will regulate the processing of personal data of data subjects by Regulation of the European Parliament and of the Council (EU) 2016/679 on the protection of natural persons regarding the processing of personal data and on free movement of data (General Data Regulation). Protection) and Law No. 18/2018, on the protection of personal data and amending certain laws.

2. Purposes and legal basis for processing personal data:

If there is a contractual relationship between the data subject and the operator, the operator processes personal data of the data subject based on the legal title of the contract only to the extent necessary to fulfill the purposes of this contract.

The operator processes the personal data of data subjects based on the legal title of legitimate interest and exclusively to the extent of the name, address, email, telephone number, the processing of which is necessary to achieve the purposes mentioned above. If the data subject provides the operator with his or her personal data voluntarily and without the operator's prior intervention, such personal data will be processed by the operator to the extent necessary based on the legal title of legitimate interest (for the purpose of assessing the concern). the data subject and providing a response to the data subject.

3. Duration of storage of personal data:

All personal data will be processed only to the extent necessary to fulfill the purposes set out in point 2 of these General Terms and Conditions and only for the period necessary to achieve the said purposes, but no longer than the period established by the relevant legal regulations or in accordance with these.

Personal data that the operator processes based on the data subject's legal title of consent will be processed until the consent is revoked; However, the operator may process some of this data even after withdrawing consent if there is another legal reason for doing so (e.g. to prove the accuracy and legality of the procedure for processing personal data or to enable the defense against legal claims).

Personal data that the operator processes based on the legal title of legitimate interest or personal data that the operator processes for direct marketing purposes will be processed until the data subject objects to the processing of his or her personal data.

4. Identification of recipients of personal data:

The operator may only pass on the personal data of the data subject to third parties if this is required or permitted by law or if the data subject has consented. The operator only makes personal data available to processors or other recipients to the usual extent:

Providers of external services for the operator (programming or other technical support services, server services, email sending, services related to measuring traffic on our pages and adapting their content to user preferences), Operators of backup servers or operators of technologies used by the operator who process them to ensure the functionality of the operator's respective services, to the extent necessary, the operator's legal, economic and tax advisors as well as the operator's auditors, who process these for the purpose of advising the operator.

5. Rights of those affected:

(Right of access to personal data) The data subject has the right to request from the operator, based on a request, confirmation as to whether or not personal data of the data subject is being processed and, in the affirmative, to request the provision of this information about the processing of personal data of the data subject. The data subject has the right to rectification of personal data concerning him or her regarding the purpose of the processing of personal data, as well as to the completion of incomplete personal data. In the event of processing of personal data based on the legal title of the contract or on the legal title of the data subject's consent, the data subject has the right to portability of the personal data concerning him that he has provided to the operator in a structured, common and machine-readable manner Format if personal data of the data subject is processed in an automated form and before the expiry of the personal data retention period. The exercise of this right must not have a detrimental effect on the rights of other persons. The data subject has the right to dispose of the personal data (the right to erasure of personal data) that are the subject of the processing if:

Personal data is processed in violation of the law or based on the withdrawal of the data subject's consent (in the case of processing personal data, based on the legal title of the data subject's consent) or The data subject objects to the processing of personal data processed on the basis of the legal title of the Operator's legitimate interest and the Operator's legitimate reasons for processing personal data do not prevail, or the personal data is no longer necessary for the purpose for which it was collected or otherwise processed. After the expiry of the retention period for personal data. The right to dispose of personal data in accordance with point five letter d) does not apply if the processing of personal data is necessary for the operator:

Exercising the right to freedom of expression or exercising the right of access, fulfilling the obligations provided for by Law No. 18/2018 on the Protection of Personal Data and amendments to other laws (in force from May 25, 2018) or special regulations,

Exercising a legal right for archival purposes, for scientific purposes, for historical research purposes or for statistical purposes in accordance with Section 78 (8) if it is likely that the law pursuant to paragraph 1 will make the achievement of the objectives of this processing impossible or seriously difficult. The right to restrict the processing of personal data if: the data subject objects to the accuracy of the personal data, during the period allowing the operator to verify the accuracy of the personal data and

any update of the personal data, the processing of personal data is unlawful, and the data subject objects to the deletion of personal data and instead requests the restriction of their use, the operator no longer needs the personal data for the purposes of processing personal data, but the data subject needs them to exercise a legal right, or the data subject objects to the processing of personal data in accordance with Section 27 (1) GDPR. 1 of Law No. 18/2018 on the Protection of Personal Data and amending other laws (valid from May 25, 2018), pending verification whether the legitimate reasons of the operator prevail over the legitimate reasons of the data subject.

The right to object to the processing of personal data:

The data subject has the right to object to the processing of personal data concerning him in all cases in which the legal right to the processing of personal data exists in the legitimate interest of the operator. The data subject has the right to object to the processing of personal data concerning him or her, even if such personal data are processed for the purposes of direct marketing, including profiling to the extent that it is related to direct marketing. If there is a suspicion that personal data is being processed without authorization, the data subject has the right to submit a proposal to initiate a personal data protection procedure to the Office for Personal Data Protection. If the legal ground for the processing of the data subject's personal data is his or her consent, the data subject may revoke this consent at any time, free of charge, at the email address provided below. Withdrawal of consent will not affect the lawfulness of processing based on consent given before its withdrawal.
